1. Jonathan Fullwood Aged 35. Convicted of Felony at Epiphany Sessions 1787 - Ordered to be Imprisoned 2 Years and to pay a fine of £10.
2. Ann Price Aged 19. Convicted of Felony at Summer Assizes 1787. Ordered to be Transported beyond the Seas for 7 Years.
3. James Theynell Aged 33. } Convicted at the same Assizes of a Riot and Assault
4. Thomas Medlicote Aged 30. } Ordered to be Imprisoned One Year, and until they
5. William Powell Aged 31. } with two Sureties each enter into Recognizances
6. James Jones Aged 36. } themselves in £10 each and the Sureties in £20
each on Condition that they keep the Peace &c for 3
Years to be Computed from the end of the Years Imprisonment, but in Default thereof the whole of their Imprisonment is not to exceed four Years.
7. Matthew Smith Aged 28. Convicted at Epiphany Sessions 1788 of buying ends of Yarn. Ordered to be Imprisoned 12 Calendar Months and then Discharged. —
8. Ann Stockwell at Harvey Aged 35. } Convicted of Felony at Lent Assizes
9. Ann Davis Aged 15. — } 1788, Ordered to be severally Transported
10. Elizabeth Stringer Aged 23. — } beyond the Seas for 7 Years. —
11. Abel Cornock Aged 25. Convicted at Easter Sessions 1788 of buying ends of Yarn &c. Ordered to be Imprisoned 6 Calendar Months.
12. Richard Williams Aged 66. Convicted at the same Sessions of buying the refuse of Cloth. Ordered to be Imprisoned 6 Calendar Months
13. John Bruton Aged 36. Convicted at the same Sessions of buying a Quantity of the refuse of Cloth. Ordered to be Imprisoned Six Calendar Months.
14. Mark Terrett Aged 55. Convicted at the same Sessions of buying Spanish ends of Yarn &c. Ordered to be Imprisoned 2 Years.
15. Thomas Reynolds Aged 30. Ordered at the same Sessions to be Imprisoned 6 Calendar Months, unless he shall in the mean time Execute a Conveyance for Charging his Estate with the Payment of 3. 0. 0⁰ Week for the Support of his Wife and Child. —

16. Richard Bushell Aged 35. Brought in December 14. 1787th Committed by G. Hayward Clerk for 12 Calendar Months or until he pays the Penalty of £20 being Convicted of stealing two Beech Trees from a Wood belonging to Lord Ducie.
17. Stephen Trigg. Aged 32. Brought in February 2. 1788 Comm^d by S. Hayward Esquire for 6 Months or until he shall pay a fine of £2.10.0 and 15. Charges being Convicted of cutting down an Oak Timber Tree in his Majesty's Forest of Deane.
18. John Morgan Aged 25. Brought in February 12. Comm^d by S. Hayward Esquire for One Year unless he shall in the mean time pay a forfeiture of £30 being convicted of stealing a Deer in his Majesty's Forest of Deane.
19. Robert Bence aged 20. Ordered into Custody March 29. th to take his Trial at the next Assizes for Perjury.
20. John Frowen aged 21. Brought in April 5. Comm^d by S. Hayward Esquire Charged by the Oath of Thomas Saylor of being concealed under the Cutting-board in his Parlour &c.
21. William Bateman, aged 11. Brought in April 24. Comm^d by J. A. Small D.D. Charged on Suspicion of stealing a Calf value 7. the Property of John Short.
22. Peter Payne aged 30. Brought in May 5. Comm^d by S. Hayward Esquire Charged on Suspicion of stealing and carrying away from a Verd-y-Grease Work 17 pounds of New Copper the property of John Hopkins.
23. Richard Hobbs aged 27. Brought in May 9. Comm^d by W. Phelps G^{nt} Colonel Charged with Murdering one Samuel Millsome.
24. William Hopkins aged 21. Brought in May 23. Comm^d by S. Hayward Esquire Charged on Suspicion of stealing from her Moorings in the River, Severn, One Boat the property of William Hawkins.
25. Anselm Parsons Aged 60. Brought in May 31. Committed by Sir John Guise Bart. Charged on Suspicion of stealing in a Ground One Weather Sheep the property of one John James.

26. John Teague aged 10. } Brought in June 3.rd Comm.^d by A. Edgar Esquire

 27. William Mishman Aged 25 } Charged with burglariously breaking open the
 Dwelling house of the Rev.^d Mr. William Spence
 and stealing therein a Flock Bed, Bolster and
 Blanket and a Sheet and Rug value 5. the
 property of the said Mr. Spence.
28. William Hewlings Aged 10. } Brought in June 7.th Comm.^d by C. J. Morgan
 and
 29. Jonathan Griffiths Aged 13. } Esquire charged with stealing in a Waggon
 of Mess.^{rs} Thomas and John Creed a Box
 containing two coats two Waistcoats two Pair of
 Breeches and other Wearing Apparel Value 15. the
 property of Thomas Morgan.
30. John Birchell at Birch Aged 21 } Brought in June 19.th Comm.^d by W.^m
 and
 31. John Astell at Bars Aged 38 } Buckle Esquire charged on suspicion
 of stealing from a Stable a Black Mare
 Value 16 Guineas the property of Richard Roberts.
32. Thomas Jeffers Aged 38. Brought in June 20.th Comm.^d by J. A. Small
 D.D. charged on suspicion of stealing a dark brown
 Gelding value £14, the property of Catherine Cripps.
